Plugsurfing currently connects over 2 million EV drivers to its EU+² wide reliable charging network operated by 500+ charge point operators (CPOs) across Europe. Combined with Ayvens' fleet management expertise, its #1 multi-brand EV fleet of +600,000 electric vehicles (EVs) worldwide and extensive market presence, the two companies aim to provide a best-in-class charging experience to further facilitate the transition towards smarter and greener mobility for corporate and SMEs clients in Europe. The partnership is expected to be progressively rolled out in the coming months, starting with Belgium, France, Germany, Italy, the Netherlands and the United Kingdom.
