## Purchases performed by ALD under its share buyback programme

ALD reports share buyback transactions executed between 13 May 2022 and 18 May 2022, under Article 5 of Regulation (EU) No 596/2014 on Market Abuse Regulation and Article 3(3) of Delegated Regulation (EU) 2016/1052 supplementing Regulation (EU) No 596/2014 through regulatory technical standards concerning the conditions applicable to buyback programs and stabilization measures.
