Acquisition

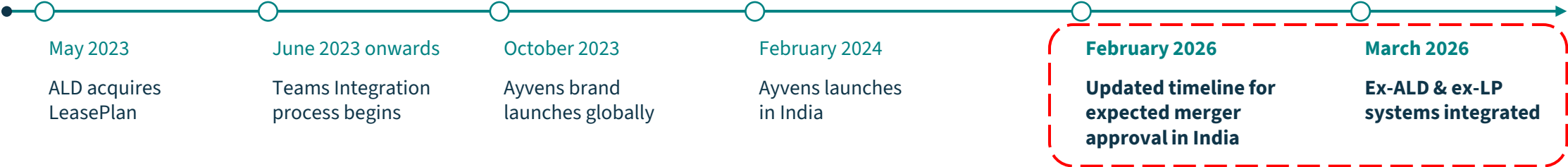
May 2023, ALD Automotive successfully completed 100% acquisition of LeasePlan. ALD Automotive Pvt. Ltd. (ALD India) and LeasePlan India Pvt. Ltd. (LeasePlan India) are in process of merger in India.

New Brand Launch

February 2024, ALD Automotive | LeasePlan India launched 'Ayvens' as their new global mobility brand in India, which unites the two companies together under a single common identity.

Legal Merger

Ayvens is expecting merger approval in India by **end of February 2026**. After the merger approval, merged entities will conduct business under the brand name - 'Ayvens'.



How will the legal merger in India take place?



- Assets of ALD India will be transferred to LeasePlan India.
- Surviving entity will be LeasePlan India Pvt. Ltd.
- LeasePlan name will be changed to Ayvens India Pvt. Ltd.



How does this merger impact ex-ALD clients

Enhanced Client Services

- Current services remain unaffected and, in fact, enhanced due to the merged expertise of two leading fleet management companies.
- Starting March, 2026, My Ayvens app will feature smart new functionalities *(Detailed communication regarding My Ayvens and its new features in the following slide.)*

Registration Certificate

- Registration Certificates (RC) of leased vehicles will continue “as is”.
- At the time of termination / expiration / vehicle buy-back, Letter of Name Change and No Objection Certificate will be provided to support smooth ownership transfer.

Invoicing

- GSTN will be that of LeasePlan India.
- Preponing of March 2026 invoice to February 2026 to prevent any payment delays and ensure smooth transition.
- Payment will be due as per the terms of your agreement for March 2026 lease rental. Only the **invoice issuance date is being adjusted.**

Communication Channels

- Communication channels such as Service call number, Service Booking app will remain the same.
- Email ID and WhatsApp messaging will be updated and communicated separately.



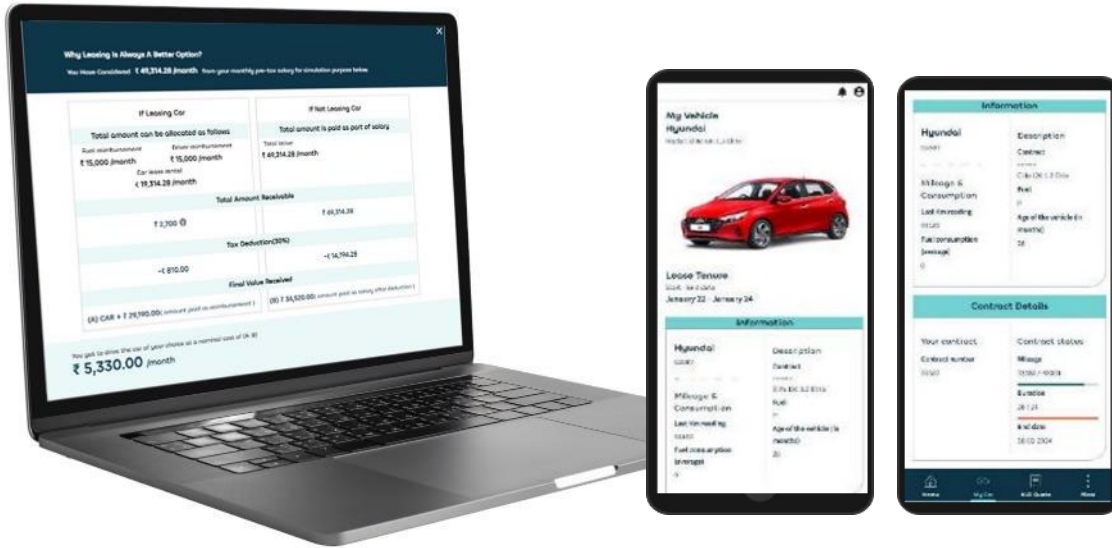




